ANALYSIS OF THE ESTIMATES & PRE-REQUISITE CONDITIONS

- 1. Model estimates for Repair & maintenance of barbed wire fencing for fixed asset & Installation of Solar Power Fencing for the F.Y. 2022-23 have been provided above. The estimated cost is inclusive of all materials to be supplied & labourers to be engaged for the purpose. Successful bidder/s should carry out the works either by deploying machine by paying minimum wage for the time in vogue. As, each of the activity requires specialized skill and experience, JFMC members who are conversant in carrying out such types of activities should be given preference while deploying labour for such types of jobs. While payment is required to be made by the contractor concerned, decision taken by the concerned Range Officer on technical ground shall be final and binding with respect to carrying any particular activities mentioned in the model estimates.
 - 2. The labourrate set c given in the estimates are asperexisting Government Rules which may be revised asperor der sinvogue.
 - 3. Rate Quoted above 20% shall be subject to rate analysis which shall require to be provided based on technical grounds to be as curtained by the Tender Committee constituted for the purpose. Rate analysis which is not technically viable shall not be accepted at this end and the candidature of the contractor

concerned shall liable to be cancelled at once. No rates quoted above the estimated rate will be entertained.

- 4. Credentials: Any bidder who has executed a single work of similar nature in last 3 years in Jhargram Division for a financial value of 40% of the total amount put to tender and credentials related document like BOQ, Estimate, Work order
- From the above analysis, it follows logically that R.A bills shall be admissible in this regard provide the concerned ROs Completion Certificate.
- 6. Issuance of work order to the L1 Bidders is subject to administrative approval and availability of fund. Similarly, payments of bills are also subject to availability of funds; the undersigned will not be liable in any such case of non-payment or delayed payment or cancellation of the tender or any other circumstances.
- Bidders cannot claim payment of Contingency amount in any way, as it is within the cost of tender
 publication etc.
- 8. The undersigned will always reserve the rights to cancel tender/ contract at any moment; even after issuance of work order, without assigning any reason whatsoever.

INSTRUCTION TO BIDDERS (ITB)

1. General Guidance for e-Tendering

1.1 Instructions/Guidelines for e-Tenderers for electronic submission of thee-Tenders online have been shown in Website https://wbtenders.gov.in

1.2 Registration of Contractors

Any contractor willing to take part in the process of e-Tendering will have to be enrolled and registered with the Government e-Procurement System.

1.3 Digital Signature Certificate (DSC)

Each contractor is required to obtain a Class-III or Class-III Digital Signature Certificate (DSC) for submission of e-Tenders.

1.4 Collection of e-Tender Documents

The contractor can search and download NIT and e-Tender documents electronically from computer once he logs on to the website mentioned in Clause 1.1 using the Digital Signature Certificate. This is the only mode of collection of e-Tender documents.

1.5 Participation in more than one work

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm or registered company. If it is found to have applied severally in a single tender, all his applications will be rejected for the same.

2. Submission of e-Tenders:

2.1 General process of submission:



Tenders are to be submitted online through the website stated in Clause 1.1 in two folders, at a time for one is Technical Proposal and the other is Financial Proposal, before the prescribed date and time mention list attached. Using the Digital Signature Certificate (DSC), the documents are to be uploaded, virus scanned digitally signed. Tenderers should specially take note of all the addendum/corrigendum related to the e-Tender upload the latest documents as part of the e-Tender.

2.2 Technical Proposal

The Technical Proposal should contain scanned copies and/or a declaration in standardized formats of the following in two covers (folders).

2.3. Financial Proposal

- i) The financial proposal should contain the Bill of Quantities(B.O.Q.)in one cover(folder). The contractor is to quote the rate in the space marked for quoting rate in the B.O.Q.
- ii) Only downloaded copy of the B.O.Q. are to be uploaded quoting the rate, virus scanned &digitally signed by the contractor.

3. Eligibility Criteria for participation in e-Tender:

- (a) The intendingbiddersshouldhaveproperlicenseforengaginglabourersoncontract.
- (b) All categories of prospective Tenderers shall have to submit valid and upto date Professional Tax receipt challan, GST registration certificate and latest GST return, Income Tax return Acknowledgement receipt, PAN card issued by Income Tax Department, Voter ID card and Trade license in respect of the prospective Tenderer. In addition to the above, any contractor who has executed any type of e-Tender works in Directorate of Forests, Gov his credentials previous submit Bengal, should Of West pastperformance, completion certificate from respective employer, the completion certificate and credentials should be significant employer. nedbythe officer not below the rank of Deputy Conservator of Forest, any other certificate signed by other officials will not be entertained(Non Statutory Documents). All categories of intending Tenderers shall have satisfactorily completed as a prime agency having taken up similar work during the last 5 (five) years prior to the date of issue of this Tender Notice as per the PWD, West Bengal G.O. No. 04-A/PW/O/10C-02/14, dt. 18.03.2015. Credentials within 3(three) years shall be preferred.
- (c) Where an individual person holds a Certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while submitting any e-Tender for and on behalf of such company or firm, invariably submit a copy of registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm, to submit such e-Tender. The Power of Attorney shall have to be registered in accordance with the provisions of the Registration Act, 1908. (Non-statutory Documents).
- (d). Neither prospective Tenderer nor any of the constituent partners had been debarred to participate in any e-Tender by Forest Dept., P.W.D., P.W.(R)D & P.W.(C.B.)D, Housing Department, W.B. or C.P.W.D. or M.E.S or Railways; during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. (A declaration in this respecthastobe furnished by the prospective bidders as per prescribed format).[Non-statutory Documents]
- (e). The partnership firm shall furnish the Registered Partnership Deed and the Company shall furnish the Memorandum of Association (MOA) and Article of Association (AOA.)[Non-statutory Documents]



n). Registered Un-employed Engineers' Co-operative Societies / Labour Co-operative Societies are required to furnish the following documents:-[Non-statutory Documents]

- (g). The prospective Tenderers or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5(five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.
- (h). Aprospective Tenderershall be allowed to participate in the job either in the capacity of individual or as partner of a firm. If the prospective Tenderer is found to have applied severally in a single job, all his applications will be rejected for that job. (i). No conditional/incompletee-Tenderwill be accepted under any circumstances.

(i). The Financial Eligibility:

- a. The bidder should have a minimum average annual turnover of least 100% of estimated project cost of the e-Tender in the last three 3 preceding years (the turnover of the lead member will be considered in case of joint venture).
- b. The bidder should have successfully completed at least one similar type of work during last three (3) years for a single contract of value not less than 80% or two contracts of value not less than 50% each.
- c. The bidders should also have made profits after taxes for each of these last three (3) financial years.

(k) Any Tenderer who has a bad reputation for his /her workmanship and/or history of non-completion of any project under this Division within the schedule time frame may be debarred from participating in the e-Tender.

(l) Engagement of technical supervisor

Successful Tenderer while executing the project work, it is mandatory to engage at least 1 (one) no. technical supervisor (Engineer with at least diploma in civil engineering having at least 5(five years) experience in supervision of similar construction works) who will supervise the entire work on behalf of the tenderer till successful completion of the project.

4. Opening of Technical Proposal

Technical proposals will be opened by the authorized representatives electronically from the website stated in Clause2.1, using their Digital Signature Certificate.

Intending Tenderers may remain present, at the time of opening of e-Tender, if they so desire.

Cover (Folder) for Statutory Documents should be opened first, if found in order, Cover (Folder) for Non-statutory Documents will be opened. If there is any deficiency in the Documents, the e-Tender will summarily be rejected.

Divisional Forest Officer

Decrypted (Trans formed into readable formats) documents of the Non statutory Cover will be down handed over to the e-Tender Evaluation Committee (constituted for evaluation of e-Tenders).

5. Uploading of summary list of technically qualified Tenderers (1stround)

Pursuant to scrutiny and decision of the e-Tender Evaluation Committee (TEC), the summary list of eligible Tenderers with the serial number of work (s) for which their Financial Proposals will be considered will be upload deed in the web portals. While evaluation, the Committee may summon the Tenderers and seek clarification information or additional documents or original hard copy of any of the documents already submitted and if these cannot be produced within the stipulated time frame, their proposals will be liable for rejection.

6. Final publication of summary list of technically qualified Tenderers

Date of opening of financial bid will to be intimated in the final summary list.

7. Opening and Evaluation of Financial Proposal

Financial proposals of the Tenderers declared technically eligible by the e-Tender Evaluation Committee will be opened electronically from the web portal stated on the prescribed date, normally after 2(two) working days of date of publication of final summary list of the e-Tenderers.

The encrypted copies will be decrypted and the rates will be read out to the contractors remaining present that time. After evaluation of Financial Proposal, by the appropriate Authority of WBFOREST, may upload the final summary result containing inter-alia, name of contractors and the rates quoted by them against each work provided E-Tender evaluation committee is satisfied that the rate obtained is fair and reasonable and there is no scope of further lowering down of rate.

8. Procedures to be followed when one/ two technically qualified Tenderers participated in any e-Tender:

Financial bid of technically qualified single / two Tenderers may not be opened. Re-Tender may be invited immediately in the process of evaluation as performs of e-TenderasperG.O.No.925/F(Y)dated14/02/2017.

9. Acceptance of e-Tender (Technically eligible/qualified)

Lowest valid rate should normally be accepted. However, the e-Tender Accepting Authority does not bind himself to do so and reserves the right to reject any or all the e-Tenders, for valid reasons and also reserves the right distribute the work amongst more than one e-Tenderer at the accepted rate after formal consultation with L1 (accepted rate) bidder and taking consent of L1bidderforsmooth&quickcompletionofthework.

10. Penalty for suppression /distortion of facts

THE PERSON NAMED IN

If any e-Tender fails to produce the original hard copies of the documents (especially completion certificates and audited balance sheets), or any other documents on demand of the E-Tender Evaluation Committee within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the e-Tenderer will be suspended from participating in the e-Tenders on e-E-Tender platform for a period of 3 (Three) years. In addition, his user ID will be deactivated and Earnest Money Deposit will stand forfeited. Besides, The Divisional Forest Officer, Jhargram Division, West Bengal may take appropriate legal action against such defaulting e-Tenderer.

12. Earnest Money Deposit (EMD):

- a) Mode of EMD Payment: Payment by NET BANKING (any listed bank) though ICICI bank payment gate way:

 gateway webpage (along with a string containing a unique ID) where he will select the bank through which
 he wants to do the transaction.

 - . If the transaction is failure, the bidder shall against for payment by going back to the first step.

13. Opening of e-Tender:

- (a) The Technical Bid shall be publicly opened by the authority receiving e-Tender or by his authorized representative, as per the Date & time Schedule mentioned in NIT.
- (b) Prospective Tenderers or their authorized representatives may be present during the opening process.
- (c) Financial Bids of only those Tenderers who would qualify in the Technical Bid evaluation will be opened.
- (d) The intending Tenderers shall clearly understand that whatever may be the outcome of the present Invitation of e-Tender, no cost of e-Tendering shall be reimbursable by the Government. The Divisional Forest Officer, Jhargram Division, W.B. reserves the right to reject any e-Tender or all Tenders without assigning any reason whatsoever and is not liable for any cost that might have incurred by any E-Tenderer at any stage of E-Tendering.
- (e) Theacceptanceofthee-TenderrestswithTheDivisionalForestOfficer,Jhargram Division, W.B.who does not bind himself to accept the lowest e-Tender and reserves to himself the authority to reject any or all the Tenders received without assigning any reason thereof.
- (f) Intending Tenderers are encouraged to inspect the site of work and get themselves thoroughly acquainted with the loc al condition and all factors which may affect their rates. Prior to the site visit the intending Tenderers must inform The Divisional Forest Officer, Jhargram Division W.B. . about the time and date of the visit.



- The selected Contractor must arrange to procure all materials required for the proper complete. work (as per the Technical Specifications of the e-Tender document). The Employer will not 14. account be responsible for procuring the same.
- 15. The selected contractor shall apply to the Divisional Forest Officer, Jhargram Division W.B. for seeking permission for utilization of land at the close proximity of the site for arranging required plant and machineries, store of materials etc. at his own cost and responsibility. All such temporary shed etc. shall have to dismantled and all debris etc. cleared from site post completion of the work or as directed by the Divisional Forest Officer, Jhargram Division, Jhargram. Once an order to the effect is issued from the Divisional Forest Officer, Jhargram Division, W.B. in this regard, it shall be brought to effect by the contractor without contest.

Bid shall remain valid for one(1) year from the date of submission of bid. Bid validity for a shorter period shall be rejected bye-Tender Accepting Authority as non-responsive.

If any Tenderer with drawshis of fer before Bid validity period without giving any satisfactor yexplanation for such with drawation of the property of the pls, he may be disqualified for submitted e-Tender to this Office and Directorate of Forests, Government WestBengalforaminimumperiodofl (one) year.

17. Verification of credentials/on site projects:

Before issuance of the work order, the e-Tender Accepting Authority may verify the credential and other documents of the lowest Tenderer if found necessary. After verification, if it is found that such documents submitted by the lowest Tenderer is either manufactured or false in that case, work order will not be issued in favour of the Tenderer under any circumstances and legal action will be taken against him.

18. Cancellation of e-Tender:

The Divisional Forest Officer, Jhargram Division, W.B. reserves the right to cancel this N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.

19. Security Deposit:

- The successful Tenderer to whom a Letter of Acceptance has been issued shall submit within 10(ten) days from the date of Letter of Acceptance, Security Deposit which is 10% (inclusive 2% of EMD)of the contracted value of work as per the G.O. NO. 201 - F (Y), dt. 18/01/2021 this shall have to be deposited in the Form TR-7 with noting Operator ID- 47 to the Jhargram Treasury. In case of written request from the L1 bidder justified with sufficient reason, provision may be made for deduction of security deposit from Progressive/R.A. Bills. Refund of Security Deposit Money and Additional Performance Security is subject to fulfillment of conditions and defect liability period as per G.O. No. 5784-PW/L&A/2M-175/2017, dt. 12.09.2017 of Principal Secretary, Public Works Department.
- If the accepted bid value is 80% or less of the Estimate put to tender the Additional Performance Security @ 10% of the tendered amount as the G.O. NO. 4608 - F(Y), dt. 18/07.2018 which shall have to be submitted by the successful bidder in the form of Bank Guarantee from any Scheduled Bank be for issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven (7) working days from the date of issuance of Letter of Acceptance, his Earnest Money will be forfeited and other necessary actions like black listing of the contractor, etc, may be taken the Bank Guarantee shall have to be valid upto end of the Contract Period and shall be renewed accordingly, if required.

The Bank Guarantee shall be returned after successful completion of the Contract and payment of bills. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the contract period.

20. Technical Specification and Quality of Works:

All works are to be carried out as per plan, specification and estimate of works subject to modification made in writing by the undersigned or his authorized officer.

21. Deduction of Taxes Etc:

Deduction of Income Tax and any other extant taxes as applicable from the Contractor's Bill will be made as per Govt. rules. Labour Welfare Cess@ 1%(one percent)of the cost of works will be deducted from every Bill of the selected agency.

22. Maintenance Period:

The Contractor will be liable to maintain the work at the appropriate service level to the satisfaction of the Divisional Forest Officer, Jhargram Division, W.B. at his own cost for a period of Security Period/Maintenance period, which is 2 (two) year from the date of completion of the project. If any defect/damage is found during the period as mentioned above, the Agency shall make the same good at his own cost. Failure to do so, penal action against the Agency will be imposed by the Government as deem fit. The Agency will have to quote his rate considering the above aspect. Also the Prospective Tenderers shall have to execute the work in such a manner so that appropriate service level of the work is kept during progress of work and the period of maintenance.
