No. 3564-WT/3M-81/98 Date: 24.11.2008 of the Transport Department, Govt. of West Bengal, the Divisional Forest Officer, Working Plans(South)-II Division, Ailakandi, Bankura, on behalf of Governor of West Bengal, invites quotation from bonafide, resourceful persons/suppliers/contractors in connection with "Hiring charges of vehicle" to prevent encroachment along the external forest boundary line as per the following estimates and location details.

## Terms & Conditions.

- 1. The Plain Paper Quotation should be submitted in sealed cover by hand or Post.
- 2. The Suppliers should quote the rates in figures as well as in words.
- 3. Quotation is floated with an anticipation of administrative and financial approval from appropriate authority. If approval is not received or fund is not there, the quotation shall be cancelled outright without assigning any further reason. Work order, after completion of due formalities shall be issued accordingly. Payment for availing quotation paper, if any shall not be refunded under any circumstances.
- 4. Rate quoted should be inclusive of all statutory taxes after proper scrutiny of model estimate if any.
- 5. Intending bidders shall have to quote the overall rate. However, if any of the items is not required to be implemented works in the field; bills should be prepared accordingly on pro rata basis based on the offered rate of the successful bidders and item wise allocation of the maximum admissible cost.
- 6. It is mandatory to pay Minimum Wage, if any, as per the latest Minimum Wage Act. It shall be the discretionary power of the Range Officer to deploy labourers from among the JFMC members/ near areas having the requisite skills to complete the works.
- 7. The Divisional Forest Officer, Working Plans (South)-II Division, shall have the liberty to cancel any part/cluster or the entire quotation without assigning any reasons thereof.
- 8. The requisite certificate such as PAN, GST, Professional Tax clearance certificate along with Bank A/c Details shall have to submit along with quotation.
- 9. If applicable, the security shall have to be deposited by the successful bidders. The security money rate may be under the discretionary power of the undersigned.
- 10. Work Order shall be issued as per exact field situation. Bill shall be processed as per actual work done in the field and not based on lowest rate quoted only, subject to the limit mentioned in the table above.
- 11. Work should be completed on dates mentioned in the work order.
- 12. It shall be the discretionary power of the undersigned to impose penalty to the tune of 10% of the total value of the work in case of delay in completing the work, if applicable
- 13. The quotationer/supplier/contractor should have valid trade license from concerned authority.
- 14. If applicable, sample should be supplied to the AFR section before quoting the rate through quotation.
- 15. Broken / Damaged/rotten materials/materials of below quality against the sample supplied, if found after receiving by this office, the same should be replaced with new one / fresh supply at the earliest.
- 16. Guarantee / Warranty of the supplied materials if any, should be indicated in the quotation.

- 17. Delivery of the materials should be free of cost.
- 18. The rate offered should be valid for 3(three) months. However the same can be increased up to 1 year subject to satisfactory service of the quotationer.
- 19. Actual work at field level shall be dependent on the field level situation as per recommendation of the concerned Range Officer. Payment will be made based on actual supply / work done.
- 20. The Concerned Range Officer will be at his/her liberty to engage skilled labourers from among the FPCs; but payment as per minimum wage act, shall be required to be made by the contractor concerned.
- 21. The work will be executed under direct supervision of concerned authorized Officer.ie. Range Office, Beat Officer or decided by the undersigned.
- 22. The Quotataioners should also have to submit ECS mandate to facilitate the payment as per present financial system if required, and if decided by the Range Officer concerned, payment to the labouers shall be given directly to the respective bank accounts of the laboueres. Successful bidder shall not have any say regarding the matter.
- 23. Work order will be issued to the successful quotationer as and when required and subject to availability of fund from appropriate authority.
- 24. In no case, the Department of Forest, any staffs of Working Plans (South)-II Division shall be held responsible for any accident/death of the labourer engaged in the field during the time of work. Safety and security shall be exclusively the concern of the successful bidders and he/she shall have to pay the compensation for such incidences as per existing rules.
