MINUTES OF THE FOREST PRODUCE DISPOSAL & PRICE FIXATION COMMITTEE MEETING

The Forest Produce Disposal and Price Fixation Committee held its meeting at 11.30 AM on 1st November 2018 at Aranya Bhawan. The Agenda Items as listed were discussed in light of the corresponding agenda notes for the meeting, as circulated before hand and the following decisions were taken there on:

AGENDA 1: (A) Requirement of Timber by WBFDC Ltd.

The Committee took note of the fact that during 2017-18, WBFDC Ltd was allotted 630 m³ of timber out of which approximately 304.628 m³ of round timber was lifted by WBFDC Ltd. Balance timber could not be lifted as explained by WBFDC Ltd officials because of non-availability of suitable timber, GST related issues and other issues. Actual status of timber lifting for 2017-18 and approved allotment of round timber to WBFDC Ltd. for 2018-19, for running its joinery and carpentry units would be as given below:

The Committee decided that for the year 2018-19 the total round timber to the tune of 800 m³ may be allotted to WBFDC Ltd. for use in various joinery and carpentry units. The validity of said allotment, including the corresponding lifting, has been decided to be upto 31st October 2019.

AGENDA 1(B) Fixing the Rates for supplying to WBFDC Ltd.

The Committee also considered the price of round timber to be allotted to WBFDC Ltd, as in its last meeting in November 2017, for running their carpentry and joinery workshop. The prices approved by this Committee, as in table below, were valid upto 31-10-2018. The matter of increasing the rates in 2018-19 was also discussed but it was agreed that due to introduction of 18% GST online the price of all the timber has increased, so it was found appropriate not to increase the rates and the following rates were approved for the forthcoming year from 1st November 2018 with a validity upto 31-10-2019:
