Please find enclosed, a copy of the communication cited above, as received from the Deputy Inspector General of Forests (FPD), MoEF&CC, Government of India regarding the Forest Fire Preparedness.

Accordingly, the State has been advised to undertake the following actions in the current fire season:

1. Mapping of assets/equipment to deal with Forest Fire be done at State/District level

2. Mapping of Water bodies for provisioning of water by the Air Force helicopter required for dousing fire by helicopter

3. Mapping of Helipads with coordinates near such water bodies, suitable sites for helipad be identified near water bodies where helipads do not exist.

The contact details of NDMA as per the communication enclosed need to be taken note of to seek assistance in case of any crisis situation arising due to forest fire.

In this regard it is requested to compile the information as required at S.No 1-3 above (District wise for each Circle) and forward the same to the Conservator of Forests, Working Plan and GIS Circle, West Bengal for further needful action at this end, preferably with in 5th February 2017.

Subject: FINANCIAL SUPPORT TO STATES AND UTS FOR CONDUCT OF MOCK EXERCISE

- 1. Mock Exercises (ME) help in evaluating administrative response to disasters by improving coording within various government departments, non-government agencies and communities. It helps in identiti the extent to which the SOPs and Plans are effective and also aid in revising these plans it requi Therefore ME on various types of perceived disasters need to be conducted at regular intervals,
- 2. Every year NDMA seeks inputs from all States & UTs on the details of the ME that they would like to conducted. These are compiled into an Annual ME Calendar and issued to all stakeholders including ND Army, CAPF, NGO etc. In this manner, NDMA in able to conduct approx 35-40 ME at the District level. NE also conducts ME as part of their Area Familiarization Programme. It will be appreciated that this in hig inadequate given that there are 36 States & UTs and 683 districts in India.
- 3. In order to make India disaster resilient and ensuring that all the State Governments & Union Territor are fully trained and organized to handle major disasters effectively, the respective State Governments / UT District authorities will have to take the ownership of this responsibility. The type of ME will be decided by I District / State Hq / UT Hq based on their respective vulnerability profile
- 4. Financial Support. An advance of Rs. One lac per District / State Hq / UT Hq will be provided by NDN for the number of districts for which the State Govis / UTs forward their consent. Funds will be transferred the State Govts / UTs as Grant-in Aid General - 3601 to States, 3602 to UTs with Legislature and through Authority to UTs without Legislature. States / UTs will be required to submit a consolidated Utilization Certificate and Expenditure Statement after completion of MEs. Unspent money for the places where M could not be conducted will be returned to NDMA.

Procedure

- (a) All States / UTs which are willing to conduct the Mock Exercises will forward their willingness to NDM. by 30th dune by fax / email, so that the required funds are released to the respective States / UT before the onset of monsoons to enable those vulnerable States/UTs to conduct Mock exercises at the earliest.
- (b) The consolidated list of Districts / State Hq / UT Hq specifying the period and type of disaster on which ME is proposed to be conducted shall be forwarded to NDMA by respective States / UTs. The Mocl exercises will be conducted under the supervision of Chief Secretary at the State / UT level and Distric Collector / District Magistrate at the district level.
- (c) States / UTs will be required to submit a consolidated six monthly report (Both in hard and soft copy) on the conduct of Mock Exercise specifying the type and number of Mock Exercises in their States / UTs. They will also be required to share lessons learnt, suggestions and gaps, if any, which require action by NDMA along with photographs,
