Review in respect of Wildlife Management in North Bengal.

Sir,

In the last few weeks a disproportionate number of deaths of wildlife and human beings have taken place in North Bengal. These have taken place in the districts of Alipurduar, Jalpaiguri, Kalimpong and Darjeeling in almost all the forest divisions of these districts. An incidence of Rhino poaching has also taken place in Gorumara National Park. These incidents reflect certain slackness in field formations or some institutional issues which need to be reviewed and rectified immediately. In this connection, the undersigned along with other senior officials of the Directorate desires to hold a review of Wildlife Management in North Bengal shortly. The date of such review will be intimated in due course. For a fruitful discussion and finalizing the future strategy, there is an immediate need to collect some information from the field.

So, you are requested to direct all DFOs/DFDs under your control to send the following information immediately along with their suggestions regarding improvement of Wildlife Management in North Bengal.
