# Minutes of the Forest produce Disposal & Price Fixation Committee Meeting held on 02.02.2021 at Conference Hall, 8<sup>th</sup> Floor, Aranya Bhawan, Kolkata

The Forest Produce Disposal and Price Fixation Committee held its meeting at 12 noon on 02.02.2021at 8<sup>th</sup> Floor Conference Hall, Aranya Bhawan. The agenda items, as listed, were discussed in light of the corresponding agenda notes for the meeting, circulated before hand and the following decisions were taken thereon:

#### Agenda 1: Requirement of timber by WBFDC ltd.

During 2019-20, WBFDC Ltd. was allotted 755 m<sup>3</sup> of timber out of which 269.212 m<sup>3</sup> of round timber was lifted by WBFDC Ltd. Balance timber could not be lifted because of non-availability of orders, the lock down situation arising out of Covid 19, which resulted in closure of joinery units and the consequent decrease in demand. Actual status of timber lifting and requirement for 2020-21, which was approved by the committee, is given in Table 1 below:

It was noted that the last revision of this rate was done in 2017-18 and the same rate, i.e.Rs.50 per cubic metre continues at present and it is valid uptill 31<sup>st</sup> March 2021. Considering the fact that the main demand for this material comes not from members of the general public but from contractors of Government Departments/Works and in view of the fact that these materials are forest produce, the committee approved the rates for Stone Boulder, Gravel, Shingels and Sand Boulder for North Bengal as per the Table 10 above effective from 16.9.2021, i.e. after the monsoon season. The rate so fixed will be excluding truck entry fees which are mandatory for entering national parks and sanctuaries, TP fees and other applicable taxes.
