Order

Sub: Declaration of ADFOs as Drawing & Disbursing Officers.

This order is issued as follow-up on the directions of Forest Department Notification No. I/28024/2018 dated 26.09.2018 wherein the Forest Department has ordered the taking over of the functioning of Drawing & Disbursing Offices in the Divisions/Circles by the Asstt. Divisional Forest Officers posted in the respective Divisions/Circles. In the said notification, Forest Department has also directed that in case, there is no ADFO in the Division/Circle then the present DFOs/Circle In-charge will continue to act as DDO till the posting of an ADFO in the Division/Circle. Further, under the notification, Forest Department has empowered PCCF' HoFF, West Bengal, to select the ADFO for DDO function, in case there is more than one posted in the establishment.

In compliance to the above notification of the Forest Deptt. the ADFOs listed in the Annexure with this order shall take over the charge of DDOs from 1st of December, 2018.

Whereas the Forest Department vide its notification has directed the taking over the functioning of DDO responsibilities by the ADFO, it does not imply that the ADFO's will have any exclusive financial powers vested to him. He will act merely as an instrument of the Division for the smooth functioning of the administration of the divisions. In order to ensure smooth transition of the DDO functioning to the ADFO's the following instructions will be complied by one and all in the divisions / circles.

- 1. All the Financial powers of the divisions will remain vested with the DFO / Circle in charge as per the West Bengal Financial Rules and the Delegation of Financial Power Rules, 1977 as amended from time to time.
- 2. The ADFO's after taking over the functioning of DDO shall not send any bills to the treasuries without the approval of the Divisional Forest Officer / Circle in charge as the case may be.
- 3. Prior to sending the bills or running bill to the Treasuries the ADFO's shall mandatorily take approval of DFO / Circle in charge either in file or through an office order.
- 4. The preparation of estimates, planning of any activity or any work in the division will remain vested with the DFO / Circle in-charge.
- 5. Once an office order for payment of any bill has been issued by the DFO / Circle in-charge, the ADFO shall mandatorily ensure the compliance of the office order so issued.

- 6. The Drawing & Disbursing Officer will be personally responsible for the correct maintenance and timely rendition of accounts or returns in respect of public funds or stores handled in his office.
- 7. Except where otherwise specifically provided, any loss or shortage of public money, departmental revenue or receipts, stamps, stores or other properties held by or on behalf of Government, by defalcation or otherwise, including losses and shortages noticed as a result of physical verification, should be reported immediately by the subordinate authority concerned to the next higher authority.

It is directed that the instruction contained in this Order shall be complied by one and all in letter and spirit.

NOTIFICATION

Divisional Forest Officers (DFO)/Conservator of Forests (CF)/Chief Conservator of Forests (CCF)/other higher officials of different offices under Directorate of Forests are working as the Drawing and Disbursing Officer (DDO) of concerned offices in addition to their normal duties, Consequent upon day to day work pressure, it has become difficult for them to perform the duties of DDO, The matter of relieving them from the duties of the DDO was under active consideration of the Government for some time past in the public interest.

Now, In terms of Rule 4.028(2), 4.028950, 4.018(1) of WBTR,2005, the Governor is pleased to declare that the Assistant Divisional Forest Officer (ADFO) will act as Drawing and Disbursing Officer (DDO) of their respective Divisions/Circles in place of existing DDOs with immediate effect and until further orders.

It is also declared that in such cases where there is more than 1(one) ADFO in any Division/Circle, PCCF & HoFF, W.B. will select the ADFO for functioning as DDO of that Division/Circle and where no officer of ADFO rank is posted in Divisions/Circles, the existing DDO(DFO/CF/CCF/other nigher official) will continue to act as DDO till the ADFO post is filled in. As soon as any ADFO is posted he/she will act as DDO in place of existing DDO.
