Dear Shri / Smt.

You must be aware after the promulgation of Compensatory Afforestation & Management Fund Act, 2016 and Rules, 2018, the present functioning of the State CAMPA is going to be changed drastically after 30th September, 2018, and the fund flow for CAMPA related activities shall done through a system of Civil Deposit, as per the communication received from Govt. of India.

We have already approached the Finance Dept., through the Forest Dept., for notifying the accounting system.
