It is to inform you that the new Compensatory Afforestation Fund Rules, 2018 has been notified and the CAF act & CAF Rules will be enforced from 30<sup>th</sup> September, 2018. After that the entire funds deposited in the state specific CAF accounts will be transferred to State Fund established under the Act. In this regard we have started reconciliation with MoEF & CC, New Delhi, based on the records available in this office. However while making the records by the MoEF & CC, they have identified an unreconciled deposits by user agency from West Bengal to the Ad-hoc CAMPA, New Delhi for an amount of Rs. 6.19 crores as per the details **attached herewith (Annexure-'A')**.
