Whereas the management of a sizable number of Casual/Daily Rated/Contractual workers have been approved by the Department of Forests, Government of West Bengal in recent past. These workers are working in different units of this Directorate.

And whereas these workers have also been awarded the terminal benefits as per Govt. orders issued time to time. As per latest GO vide No.1107-F (p) dt.25.02.2016 some terminal benefits have been added by the Govt. which are to be awarded in a time bound manner. It requires special attention and care by their controlling units for each individual worker in order to maintain continuity. It is very much needed to keep records for future benefit settlement.
