Dated, Kolkata, the September 24, 2018.

Whereas, the concerned head of office bears the responsibility to open the Service Book of any employee after his appointment under the Government and whereas every step in the official life of any employee of the Government must have to be recorded and each entry must have to be attested by the head of office of the Government employee and

Whereas it is the responsibility of the concerned head of office to see that all entries are duly made and attested in the Survive Book of any Government employee under his control and it is the responsibility of the concerned Head of office to ensure that the Service Book of the Government employee contains no erasure of overwriting,, according to Appendix 7 of West Bengal Service Rules Part – I and although the rules of West Bengal Service Rules Part – I provide ample guidelines as far as opening and maintenance of Service Books of Government employees, it has been observed that due to retirement, transfer, deputation etc. of the concerned head of office, or any other lacuna, the job of the opening as well as maintenance of Service Book of employees of the Government gets hampered; which may cause harassment on the part of the Government employee, without any of his fault and

Whereas according to existing rules of the Government states that, the eligibility of a Government employee belonging to Group - 'B', 'C' & 'D' for functional promotion to the higher post or non-functional promotion of availing benefit under Modified career Advancement Scheme is assessed on Performance appraisal Reports of last three consecutive years. But for time and again, it has been observed many a times that the said Performance Appraisal Reports of a Government employee belonging to Group - 'B', 'C' & 'D' have not been submitted to the concerned authority in due time, due to retirement, transfer, deputation etc. of the respective officers, eligible to endorse them. As a result, process of availing benefit of functional or non-functional promotion by a Government employee belonging to Group - 'B', 'C' & 'D' gets hampered, which causes financial loss to the incumbent concerned, for which he is not responsible in any way and

Whereas, according to guidelines provided in notification no. 3940 (280)-F dated 28-03-1978, 5791-F dated 11-06-1980 of the Finance Department, Government of West Bengal & memo number 224-P & AR (Viz) dated 12-06-1980 of PAR Department, Government of West Bengal, as far as issuance of No Bar Certificate in connection awarding promotion to the Government employees belonging to Group - 'B', 'C' & 'D' is concerned.

- This is hereby ordered that, in case of retirement, transfer, deputation etc, of the respective officers entitled to open Service Book of any Government employee and to maintain it, the officer presently holding the post may complete the job, on the basis of available records.
- 2. This is hereby further ordered that, in case of retirement, transfer, and deputation etc, of the respective officers endorsing the Performance Appraisal Reports (OPRs), the officers presently holding the posts may take accordant action to complete the process of evaluating those reports, on basis of available records. Memo number

642/PMC/2E-995/2013 dated 22-04-2013 (copy enclosed) of office of the Principal Chief Conservator of Forests & Head of Forest Force, West Bengal may be referred in this regard.

- 3. This is further ordered that, controlling officers should go through the Service Book of the concerned Government employees in details, before issuance of such NO BAR CERTIFICATES and to follow the guidelines provided in notification no. 3940 (280)-F dated 28-03-1978, 5791-F dated 11-06-1980 of the Finance Department, Government of West Bengal & memo number 224-P & AR (Viz) dated 12-06-1980 of PAR Department, Government of West Bengal, in order of issuance of them. Memo number 13756/PMC/2E-809/A/16 dated 21-03-2016 (copy enclosed) of office of the Principal Chief Conservator of Forests & Head of Forest Force, West Bengal may be referred in this regard.
- 4. This is further ordered that, controlling officers of all units of the Directorate of Forests, Government of West Bengal must submit following testimonials of any Government employee to the controlling officer of new place of posting of the incumbent, when the Government employee gets transferred from his unit,
 - Updated Service Book in original,
 - b. Previous Personal File(s),
 - c. Last Pay Certificate &
 - Other testimonials like OPEN PERFORMANCE REPORTS in original of the previous years.

Status of following items must be mentioned in the Last Pay Certificates.

- I. Casual Leave,
- II. Uniform Articles received.
- III. Existence of any Departmental proceedings or not.

The above order must be followed literary as well as in spirit.

Writing of OPEs in respect of the incumbent belonging to Group-B.C & D

I am directed to inform you that the eligibility of an incumbent belonging to Group-B, C and D for promotion to the higher post or for awarding MCAS is assessed on the basis of the last 3 years' consecutive OPRs. But it is seen from the past records that the said OPRs of an incumbent belonging to Group-B, C & D may not be possible to submit in time due to retirement, transfer, deputation etc. of the respective officers endorsing the OPRs. As a result, the promotion/MCAS in question of an incumbent belonging to Group-B. C and D is badly hampered and the employee has to face both promotional and financial loss in the service carrier.

In this connection I are also directed to inform you that as in the case of retirement, transfer, deputation etc. of the respective officers endorsing the OPRs, the officers presently holding the post may initiate/write the OPRs on the basis of the available records.

I am , therefore, to request you to act accordingly at the time of initiating/ writing the OPRs of an incumbent belonging to Group-B. C and D to overcome both promotional and financial loss in the service carrier.
