## SUB: IMPLEMENTATION OF DEVELOPMENTAL SCHEMES - EXPENDITURE

Dear Shri/Smt.

During the current Financial Year, the undersigned has issued 2 D.O. letters to you for expediting the expenditure and quick implementation of developmental schemes. As you are aware that the Financial Year closing is approaching very first and only 2 months left to complete the implementation of all developmental schemes meant for the F.Y. 2018-19. It is important to mention here that Loksabha polls will be held probably during the month of April-May, 2019 and after the notification of dates of the poll, the 'Code of Conduct' will come in force and it will not be possible to float tenders and also to implement any new projects. In addition to this, no beneficiary oriented activity can be undertaken after the code of conduct comes into force. In short, we have only 2 months left for starting all our projects and completing it within current F.Y. i.e. 2018-19.

During the last review meeting held with all the DFOs on 17<sup>th</sup> January, 2019, it transpired that expenditure is not up to the mark and under some projects, in spite of the sanctions, expenditure have not taken place at required level.

May, I therefore, request you to kindly issue instructions to all the DFO/DCFs/DFDs under your control to expedite the implementation of all developmental projects and try to achieve 100% expenditures by 31<sup>st</sup> March, 2019.
