The following items pertaining to Finance wing were discussed in the meeting:-

- 1. **Designating the ADFOs as DDOs** It was decided that all the CCFs will take responsibility and send the names of the ADFOs under the divisions as per the details contained in the Forest Deptt. letter No. 1879-FR/O/N/6M-61/16 dated 19.06.2017 (copy enclosed). It was also decided that wherever the ADFOs are not available, a certificate to that effect shall be sent to this office that in such and such divisions / circles there is no post of ADFO or no ADFO is available in the establishment. It was also decided that the few DDOs will be divested of their DDO function and their establishment will move to the nearest DDO present near their offices, viz. CCF/NC, FD/BTR, CCF/HC, DFO/Publicity and CF Research. The PCCF & HoFF, for the ease of the changeover, agreed to look into the matter of the cut of date of this change over from 1st April 2019 in place of 1st November, 2018.
- 2. The list of beneficiaries under Decentralized Peoples' Nurseries(DPN) the CCFs were requested to send the list of beneficiaries under DPN in soft copy of their respective divisions by mail to this office, to the mail ID of DCF Finance- <a href="deffin@gmail.com">deffin@gmail.com</a>. PCCF&HoFF also requested to all the CCFs, specially Circles of North Bengal to include the Aranya Bandhus in the list of beneficiaries as per the government notification.
- 3. Surrender of Funds in Plantation Heads:- The CCF's were asked to send immediately all the details of Surrendered Funds under Plantation Heads under State Development schemes. So that the funds may be utilized in time by reallocating, for other pressing activities.
- 4. Budget preparation for 2019-20 All the CCFs were requested to start preparing the estimates for the state development works for the next year, based on the allocations during the current year. CCFs were also requested to prepare the building estimates to the tune of twice the funds received this year and take all necessary steps for getting these estimates vetted by the PWD by March, 2019 under the building heads.

- 5. Funds requirement under the Salary head during the current year The CCFs were requested to send immediately the requirement for funds for the salary heads for their respective circles to avoid the stoppage of salaries by the treasuries. This will enable this office in preparing proposal for timely augmentation of funds to the Forest Deptt. The reports from following circles have not been received till date -
  - Research Circle a)
  - b) Central Circle
  - Sunderban Tiger Reserve
  - d) Wildlife (Hq.)
  - North West Circle.
  - f) CF, APM
- 6. Target for advance seedlings during 2019-20 and 2020-21 the target for the advance seedlings were received by all the circles except Soil Conservation (North) Circle. Since the CCFs could not provide the break up of the total Advance seedlings requirements between poly-pot seedlings and hyco-pot seedlings it was decided that the CCFs will send the break up of the total seedlings between poly-pot seedlings and hyco-pot seedlings along with details of sizes of the polypots and hycopots, immediately within a week, by mail to the DCF/Finance, so that the advance estimates can be sent to the Department at the earliest.
